Invitation for Bids for the **Construction and Upgrading of Solabang – Jhulkhet – Ghattekholra – Kwama – Ghorkhani Road**

1. **Musikot Municipality** invites sealed bids or electronic bids from eligible bidders for the Construction and Upgrading of **Soalabang – Jhulkhet – Ghattekholra – Kwama – Ghorkhani Road** under National Competitive Bidding – **Single Stage Two Envelope Bidding procedures**.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years : **Nrs. 4,82,00,000.00 (Four Crore Eighty Two Lakh Rupees)**.
 - Minimum Work experience of similar size and nature: **2 (Two) of 3,50,00,000.00 (Three Crore Fifty Lakh Rupees)**
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
 3. Eligible Bidders may visit PPMO e-GP system www.bolpatra.gov.np/egp.
 4. Bidders are requested to download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .

5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1.00 P.M., 2076.10.28 B.S. (2020.02.11 A.D.)** at the office of **Musikot Municipality**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRS. 24,10,000.00**, which shall be valid for **30 days** beyond the validity period of the bid.
6. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
7. Tax clearance certificates of each year must be submitted along with audit reports respectively for Turn over calculations.
8. Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
9. To establish its qualifications to perform the Contract in accordance with Section III (Evaluation and Qualification Criteria) the Bidder shall provide the information requested in the corresponding information sheets included in Section IV (Bidding Forms).
10. For complete bidding bidders are requested to fill up all bidding forms as described & provided in Section IV with supporting documents.
11. The Employer reserves the right to accept or reject any bid, and to annul the bidding process and reject all Bids at any time prior to contract award, without thereby incurring any liability to Bidders. In case of annulment, all Bids submitted and specifically, bid securities, shall be promptly returned to the Bidders.
12. Payment will be done Partially as per federal budget, provided to Musikot Municipality Each year.
